

Score with Velveeta Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Score with Velveeta (the "Promotion") is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of Kraft Heinz Foods Company ("Sponsor"), HelloWorld, Inc., ("Administrator"), Catapult Integrated Services LLC, Southeastern Conference (SEC), ESPN, Inc., and their parent and affiliate companies, suppliers as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Promotion. 3. Timing: The Promotion begins on August 1, 2019 at 12:00 a.m. Eastern Time ("ET"), ends on December 1, 2019 at 11:59 p.m. ET (the "Promotion Period"), and consists of two (2) phases (each a "Phase") as outlined below.

Administrator's computer is the official time-keeping device for this Promotion.

4. How to Enter: During the Promotion Period, visit www.scorewithvelveeta.com ("Website") and complete and submit the registration form including a valid home address. P.O. Boxes are not permitted. Then, you may proceed to enter the Sweepstakes and play the Instant Win Game as outlined below.

- a. **Sweepstakes:** There are two (2) ways to enter as outlined below.
 - I. **Make a Qualifying Purchase:** During the Sweepstakes Phase, purchase participating Velveeta Shells and Cheese and/or Velveeta Loaves as outlined in Appendix A, locate the UPC code ("Code") on the pack and keep your receipt. Take an image of your entire receipt. The receipt image must be clear and legible, include retailer name, purchase date and time, the Velveeta Shells and Cheese and/or Velveeta Loaves purchase, and the purchase price. Then, visit the Website, register (on your first visit) or login, and follow the instructions to upload the image of your receipt. You will receive one (1) Sweepstakes entry for each package of Velveeta Shells and Cheese and/or Velveeta Loaves purchased (i.e. if you purchase a three (3) pack bundle, you will receive three (3) Sweepstakes entries).
 - II. **Mail-in Alternate Method:** To enter the Sweepstakes without making a purchase, hand print your name, address, day and evening phone numbers, email address, and date of birth on a 3" x 5" piece of paper and mail it in an envelope with proper postage to "Score with Velveeta," c/o HelloWorld, Inc., P.O. Sweepstakes entry. Limit: One (1) entry per envelope. All mail-in entries must be handwritten and must be postmarked by October 31, 2019 and received by November 7, 2019. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

Limit: Each entrant may enter the Sweepstakes up to thirty (30) times during the Promotion Period regardless of method or combination of methods of entry.

- b. **Instant Win Game:** During the Instant Win Game Phase, visit the Website, register (on your first visit) or login, and advance to the Instant Win Game page to receive one (1) Instant Win Game play for that day. Once on the Instant Win Game page, play the game. The Instant Win Game results will be instantly displayed. Potential winners of the Instant Win Game will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the Instant Win Game. Limit: Each entrant may play one (1) time per day during the Promotion Period.

Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of plays/entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's plays/entries and that entrant may be disqualified. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified. In the event of a dispute as to any registration or play, the authorized account holder of the email address used to register will be deemed to be the entrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder.

5. Sweepstakes/Instant Win Game: Administrator is an independent judging organization whose decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. Sweepstakes: Administrator will randomly select the potential Sweepstakes winner, from all eligible entries on or around November 11, 2019. If you are the first player to play the Instant Win Game at or after one of the randomly-generated times, you will be a potential instant winner of the prize indicated.

Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or Instant Win Game or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
